1. Who We Are

2. What Cookies Are

Cookies are small text files stored on your device when you visit a website. Similar technologies include pixels, tags, local storage and software development kits. These technologies can recognise a device, remember preferences, keep a shopping cart working, measure website activity and support advertising.

3. How We Use Cookies

Category	Purpose	Legal basis	Typical duration
Strictly necessary	Required for core functions such as security, network management, checkout, shopping cart, account access, payment processing and remembering cookie choices.	No consent required where legally permitted	Session to 12 months
Preferences	Remember choices such as language, region, display settings or saved preferences.	Consent	Session to 12 months
Analytics	Help us understand visits, traffic sources, page performance, errors and how users interact with the website.	Consent	Session to 24 months
Advertising and social media	Measure campaigns, limit repeated adverts, build audiences and support content from social media or advertising platforms.	Consent	Session to 24 months

4. Current Cookie List

The current cookie names, providers, purposes and expiry periods are available through the Cookie Settings panel in the website footer or cookie banner. That panel forms part of this Cookie Policy and is updated when the website's cookie configuration changes.

5. Consent and Cookie Settings

When you first visit the website, you are given a clear choice to accept or reject non-essential cookies. Strictly necessary cookies may operate without consent because the website cannot provide the requested service without them. Your consent choices are stored so the website can remember them.

You can change or withdraw consent at any time by selecting Cookie Settings in the website footer. Withdrawal does not affect the lawfulness of processing carried out before consent was withdrawn.

6. Third-Party Cookies

Some cookies may be set by third-party services used for payments, analytics, advertising, embedded media, social sharing or security. Those providers may combine information from the website with information collected elsewhere, subject to their own privacy policies. Non-essential third-party services load only after the required consent is given.

7. Managing Cookies Through Your Browser

Most browsers allow you to view, delete or block cookies. Blocking strictly necessary cookies may stop the shopping cart, checkout, account or other website functions from working correctly. Browser controls do not always prevent pixels, server-side technologies or similar tools, so the website Cookie Settings should be used as the primary consent control.
